Mr. Fair answered questions from the Board and provided information regarding the structures on the property. Discussion was had by the Board as well as Solid Waste Director Sam Lunsford.

Donna McKinley appeared before the Board to request that property owned by her which had been billed for two (2) Solid Waste Availability Fees be refunded one (1) of the fees that she had already paid. Ms. McKinley answered questions from the Board and provided information about the structures on the property.

Mr. Lunsford answered questions from the Board and provided information regarding the structures on the property. He also noted that Mr. Worley had been billed for two (2) Solid Waste Availability Fees and had requested the release of one (1) of the fees.

Larry English appeared before the Board to request that the Solid Waste Availability Fee assessed to property owned by him be released. He answered questions from the Board as well as provided information regarding the structure on the property.

Carolyn Ammons appeared before the Board to request that the Solid Waste Fee assessed to property owned by her be released. She answered questions from the Board and provided information about the structures on the property. Discussion was had by the Board.

Kenneth Fowler appeared before the Board to request that the Solid Waste Fee assessed by property owned by him be released. He answered questions from the Board and provided information about the structure on the property.

Wilson Kent appeared before the Board to request that the Solid Waste Fee billed to property owned by him be released. He answered questions from the Board and provided information about the structure on the property.

Solid Waste Director Sam Lunsford appeared before the Board on behalf of Ellen Hensley. Mr. Lunsford answered questions from the Board and provided information regarding the structures on the property. He also noted that Ms. Hensley had requested the refund of one (1) Solid Waste Availability Fee.

Owen Ball appeared before the Board on behalf of Lyndal English to request that a Solid Waste Fee billed to property owned by Mr. English be refunded. Solid Waste Director Sam Lunsford appeared before the Board on behalf of Glenn Reems to request a refund for Solid Waste Availability Fees which had been paid by Mr. Reems. Mr. Lunsford answered questions from the Board and provided information regarding the structures on the property. He noted that Mr. Reems had been charged for five (5) Solid Waste Availability fees and that only one structure on the property should have been billed.

Solid Waste Director Sam Lunsford appeared before the Board on behalf of Albert Rice to request a refund for a Solid Waste Availability Fee which had been paid by Mr. Rice. Mr. Lunsford answered questions from the Board and provided information regarding the absence of any structure on the property.

Solid Waste Director Sam Lunsford appeared before the Board on behalf of Juanita Nash. Mr. Lunsford answered questions from the Board and provided information regarding the structures on the property and noted that Ms. Nash had requested a refund for one (1) of the two (2) Solid Waste Availability Fees which had already been paid.

Solid Waste Director Sam Lunsford appeared before the Board on behalf of Harold Ledford. Mr. Lunsford answered questions from the Board and provided information regarding the structure on the property and noted that Mr. Ledford had requested a refund for the Solid Waste Availability Fee which had already been paid.

Solid Waste Director Sam Lunsford appeared before the Board on behalf of Elva Marler. Mr. Lunsford answered questions from the Board and provided information regarding the structure on the property. He noted that a refund for the Solid Waste Availability Fee which had already been paid had been requested.

Discussion was had by the Board. Upon motion by Commissioner Wechtel and second by Commissioner

Gentry, the Board voted unanimously for a five minute recess at 5:20 p.m.

Upon motion by Commissioner Gentry, the Board voted unanimously to return to business at 5:29 p.m.

Discussion was had by the Board regarding the Solid Waste Availability Fee and how properties are assessed the fee. Counsel was provided by County Attorney Donny Laws who answered questions from Board members and discussion was had by Attorney Laws and the Board regarding the fee.

Discussion was had by the Board regarding the request of the Astronomy Club. Chairman Snelson made a motion to release in favor. The Board voted 3-2 against with Commissioner Gentry, Commissioner Wechtel, and Commissioner Garrison voting opposed.

Discussion was had by the Board regarding the request by Robert Mark Fair. Upon motion by Commissioner Gentry, the Board voted unanimously to release one (1) card for the saw mill. Commissioner Garrison clarified with Solid Waste Director Sam Lunsford that the request is for a reimbursement of a fee already paid.

Discussion was had by the Board regarding the request by Donna Mckinley Hensley. Upon motion by Commissioner Gentry, the Board voted unanimously to reimburse.

Discussion was had by the Board regarding the request by David Worley. Upon motion by Commissioner Gentry, the Board voted unanimously not to release.

Discussion was had by the Board regarding the request by Larry English. Upon motion by Commissioner Gentry, the Board voted unanimously to not release.

Discussion was had by the Board regarding the request by Carolyn Ammons. Upon motion by Commissioner Gentry and second by Vice-Chairman Goforth, the Board voted 4-1 to exempt the fee with Commissioner Wechtel voting opposed.

Discussion was had by the Board regarding the request heard on behalf of Lyndal English. Upon motion by Commissioner Garrison and second by Commissioner Gentry, the Board voted unanimously to release one (1) card.

Discussion was had by the Board regarding the request by Chris Kramer. Upon motion by Chairman Snelson with further discussion being had by the Board, the Board voted 3-2 to release the fee with Commissioner Gentry and Commissioner Wechtel voting opposed.

Discussion was had by the Board regarding the request by Eric Jenkins. Upon motion by Commissioner Garrison and second by Vice-Chairman Goforth, the Board voted unanimously to release.

Discussion was had by the Board regarding the request by Jimmy Bullman. Upon motion by Vice-Chairman Goforth and second by Commissioner Gentry, the Board voted unanimously to release.

Discussion was had by the Board regarding the request heard on behalf of Glenn Reems. Upon motion by Commissioner Wechtel and second by Vice-Chairman Goforth, the Board voted unanimously to release four (4) cards and charge for one (1).

Upon motion by Commissioner Gentry and second by Chairman Snelson, the Board voted unanimously to adjourn at 7:35 p.m.
