7. I certify that I have adequate insurance to cover any injury or damage that I may cause or suffer while participating, and I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

8. I agree that the courts of Madison County, North Carolina shall be the sole and exclusive forum and venue for any action I file against SBTR & LPGM and that in the event I file a lawsuit against SBTR & LPGM, I shall do so solely in the federal or state courts of **Madison County, North Carolina.** I further agree that the substantive law of North Carolina shall apply in any such action, without regard to the conflict of law rules of North Carolina or any other state. I agree that if any portion of this agreement is found to be void or unenforceable, the separable and remaining portions shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against SBTR & LPGM on the basis of any claim from which I have released them herein.

PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

WARNING:: Under North Carolina law, an equine activity sponsor or equine professional is not liable for any injury to or death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. CHAPTER 99E of the North Carolina General Statutes

In consideration of the services of Sandy Bottom Trail Rides LLC & Long Pine Gem Mine/Little Pine Garnett Mine, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "SBTR & LPGM"), I hereby agree to release, indemnify, and discharge SBTR & LPGM, on behalf of myself, my spouse, my children, my parents, my heirs, successors, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in horseback riding, carriage, sleigh or wagon ride, Kubota rides and digging/mining activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. **The risks may include, but are not limited to:** death, head trauma, and other injuries; exposure to and travel on uneven trails or rugged terrain, collisions, and flipping over; slipping or falling; falling into open pits or trenches; landslides or collapse of excavations; equipment failure; exposure to potentially dangerous wild animals, insect bites, and hazardous plant life; exposure to temperature and weather extremes; being jolted, jarred, bounced, thrown about and otherwise shaken during rides; contact or collision with other passengers; losing control of your horse and falling; collisions with other horses or obstacles; saddle, tack, or equipment failure; my own physical condition, and the physical exertion associated with this activity. A horse, regardless of its training and usual past behavior, may act unpredictably at times based upon instinct or fright which may cause you to be thrown from your horse or injured by the horse. Horses may do such things as bite, kick, buck, rear, fall, spook, lie down, or stumble. Saddles may slip and other tack or saddle problems may develop as a result of normal use and wear. Your horse may collide with obstacles or encounter variations in terrain such as creeks, water, bridges, traveled roads, wild animals, birds, stumps, forest growth, debris, rocks and cliffs and other obstacles whether obvious or not and whether man made or natural. Riding a horse requires the participant to balance on the saddle. Accidents or illness can occur in remote places without medical facilities and emergency treatment or other services rendered.

Furthermore, SBTR & LPGM employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, other environmental conditions, the condition of the trail or terrain, or other potential hazards and risks. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks associated with this activity in any way. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I represent, state, and agree that I am **not now pregnant** and that I have no history of epileptic seizures, heart condition, and/or any other medical problem that could be affected by horseback riding. I acknowledge that SBTR & LPGM advise that pregnant women should not ride horses or engage in equine activities without the approval of my physician.

4. On behalf of myself and my minor children, I hereby voluntarily release and forever discharge SBTR & LPGM, its affiliates, successors, and assigns from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of
