Absentee Meeting Minutes

October 23, 2020

The Madison County Board of Elections met on Friday, October 23, 2020. In attendance: Jerry Wallin, Chair; Dyatt Smathers, Member; Sandra Tolley, Member; Kathy Ray, Director; Jacob Ray; Deputy Director; and one member of the public.

Call to Order:

Chair Wallin called the meeting to order at 2:00 p.m.

Preparatory Steps to Count Ballots:

The voting equipment was reconciled with the chain of custody.

Absentee Ballots' Approval from the Cancelled October 20th Meeting:

Military (MIL) Ballots

Motion, Seconded (DS, JW) and ¢arried (3,0) to approve 1 mil absentee ballot.

One Stop (OS) Ballots

Motion, Seconded (DS, JW) and Carried (3,0) to approve 1,787 one stop absentee ballots.

Motion, Seconded (DS, JW) and Carried (3,0) to go into closed session to duplicate 2 civilian ballots and 5 OVR ballots.

Motion, Seconded (DS, JW) and Carried (3,0) to return to open session.

The duplicated ballot log was created and original ballots were sealed for storage.

The Board recorded the ending ballot count of 1,391 ballots and sealed the machine for storage.

Other Matters:

The Director presented 1 one stop, curbside voted ballot that would not tabulate at Beech Glen Community Center. The voter left the site before a replacement ballot could be offered.

Motion, Seconded (DS, JW) and Carried (3,0) to approve ballot duplication and return the ballot to Beech Glen Community Center for tabulation.

Motion, Seconded (DS, JW) and Carried (3,0) to go into closed session to duplicate the one stop ballot. The ballot was sealed and signed by the board for return to the one stop site for tabulation.

Motion, Seconded (DS, JW) and Carried (3,0) to return to open session.

The Director reported a voter concern that her one stop voted ballot did not contain all the contests and candidates.

Motion, Seconded (DS, JW) and Carried (3,0) to retrieve the voted ballot for a full review of all the contests and candidates. The Board review affirmed that the voted ballot did contain all federal, state, and local contests and candidates for the election. The Board asked the Director to contact the voter regarding the Board's action and conclusion.
