VACANCY ANNOUNCEMENT PUBLIC HEALTH NURSE II MADISON COUNTY HEALTH DEPARTMENT

Salary: \$37,440

Description of Work:

The Madison County Health Department has an opening for a Public Health Nurse II to serve as the coordinator for the Breast & Cervical Cancer Control Programs and Wise Woman Program. The RN would be responsible for coordinating care for BCCCP clients, case management, overseeing the BCCCP clinics, assisting the nurse practitioner/MD, providing health education, outreach services, referrals and participating in multidisciplinary teams. The position will include working with other patient populations as well. Obtain blood pressures, urinalysis, provide immunizations to infants, children and adults, vision screens, hearing screens, administer pregnancy tests, flu, pneumonia, and COVID-19 vaccines, administer TB skin tests and reading of TB skin test per policies and standing order.

1. Public Health is a first responder agency for natural disasters (e.g., hurricanes, tornadoes, floods, winter storms), naturally occurring infectious disease outbreaks (e.g., influenza, H1N1, SARS), technological hazards (hazardous material releases, critical infrastructure). This position, like all other positions within the Department may be required to participate in any emergency response activities as deemed necessary by the Health Director or his/her designee. Availability during emergencies and exercises required.

Minimum Education and Experience:

Graduation from a four-year college or university with a B.S. in Nursing which includes a Public Health Nursing rotation and one year of Public Health Nursing experience; or Master's in Public Health and graduation from a school of professional nursing and one year of professional nursing experience; or graduation from a school of professional nursing and two years of professional nursing experience including one year of Public Health Nursing experience; or an equivalent combination of training and experience.

Necessary Special Qualifications - A current license to practice as a Registered Nurse in North Carolina by the N. C. Board of Nursing.
