3. Immediately proceed with the advertisement for upset bid as set forth in the NC General Statute 16A-2

In the event the upset bid process is elected, then upon completion of the upset bid process, the Board of Commissioners may accept this offer OR in the event of a higher upset bid, may accept that bid and sell the property to the highest bidder, OR the Board may elect to reject any and all offers.

Upon notification that said offer is accepted and there have been no further upset bids, I (we) will pay the balance of the purchase price in full by cash or certified check within ten (10) days so that I (we) may receive the deed for recording. I (we) understand that I (we) will be responsible for ALL expenses involved in the recording of the deed. If full payment is not received by the County within thirty (30) days, the deposit will be forfeited and property disposed of as allowed by North Carolina law. Madison County will convey by Special Warranty Deed to the person executing this offer unless the County has received and approved a re-assignment prior to the final approval of the offer, in which case, the deed is to be made to: (name) _____
